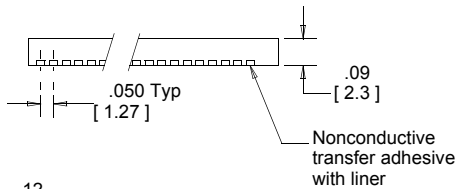
**Contact Detail**



**Recommended Board Layout**

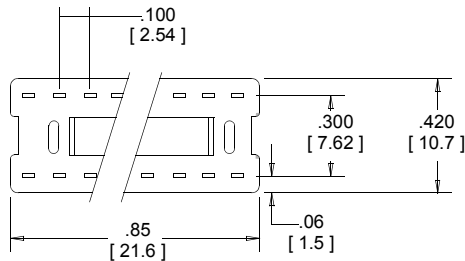
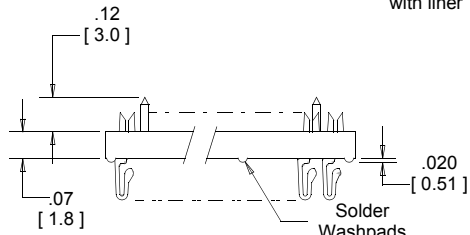


**Connector Cover**



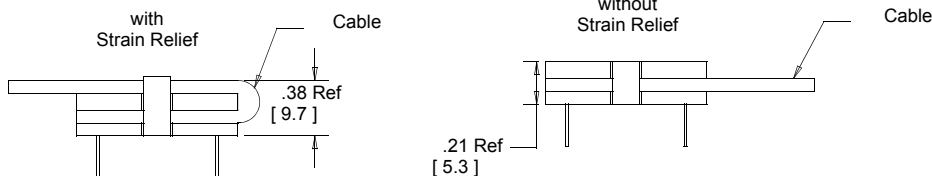
