

DESCRIPTION/ORDERING INFORMATION

This decoder is designed for 1.65-V to 5.5-V V_{CC} operation.

The SN74LVC1G29 is a 2-of-3 decoder/demultiplexer. When the enable (\overline{G}) input signal is low, only one of the outputs is in the low state, depending on the input levels of A0 and A1. When \overline{G} is high, Y0, Y1, and Y2 are high, regardless of the input states.







Figure 1. Load Circuit and Voltage Waveforms



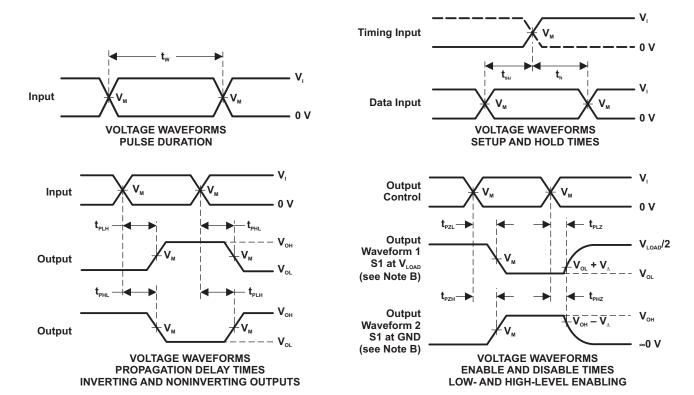


