













Gate-Source Voltage v Gate Charge




Basic gate charge waveform

Switching time waveforms




Switching time test circuit



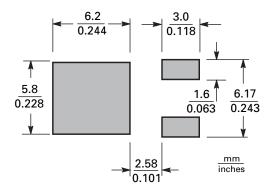
