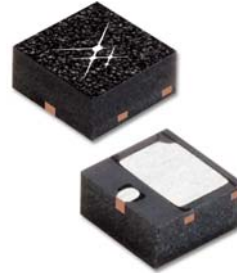

Description

The SMP1324-087LF is a surface mountable PIN diode suitable for use in an RF switch or attenuator circuit.

Maximum resistance at 50 mA is 0.75 Ω and maximum capacitance at 30 V is 1.5 pF. The combination of low capacitance, low parasitic inductance, low thermal resistance, and nominal 100 μm I-region width, makes the SMP1324-087LF useful in large signal switches and attenuator applications.

The device has a 2 W dissipation power rating, which makes it capable of handling up to 50 W Continuous Wave (CW) and 500 W peak (1 μs pulse, 1 percent duty cycle) in a shunt-connected transmit/receive (T/R) switch.

Package and Handling Information

Instructions on the shipping container label regarding exposure to moisture after the container seal is broken must be followed.

Otherwise, problems related to moisture absorption may occur when the part is subjected to high temperature during solder assembly.

The SMP1324-087LF is rated to Moisture Sensitivity Level 1 (MSL1) at 260 °C. It can be used for lead or lead-free soldering. For additional information, refer to the Skyworks Application Note, *Solder Reflow Information*, document number 200164.

Care must be taken when attaching this product, whether it is done manually or in a production solder reflow environment. Production quantities of this product are shipped in a standard tape and reel format. For packaging details, refer to the Skyworks Application Note, *Discrete Devices and IC Switch/Attenuators Tape and Reel Package Orientation*, document number 200083.

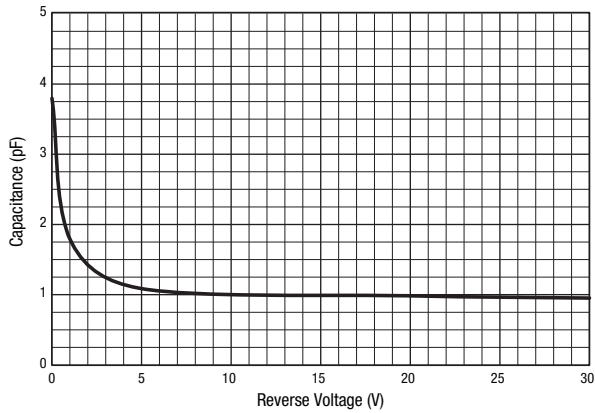


Figure 1. Capacitance vs Reverse Voltage @ 1 MHz

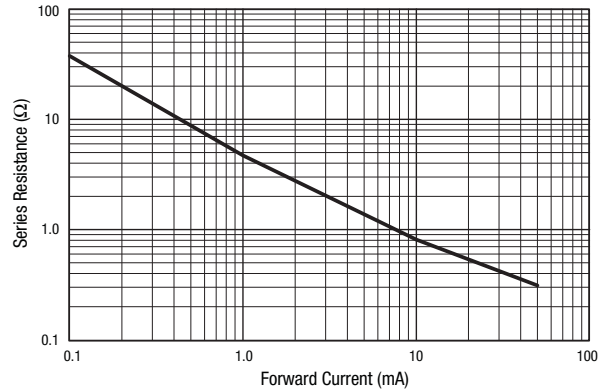


Figure 2. Series Resistance vs Forward Current @ 100 MHz

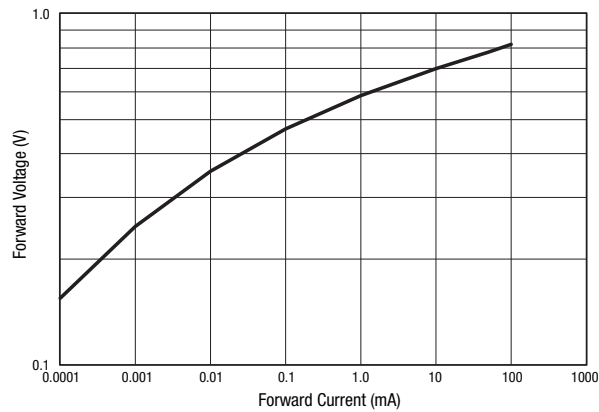
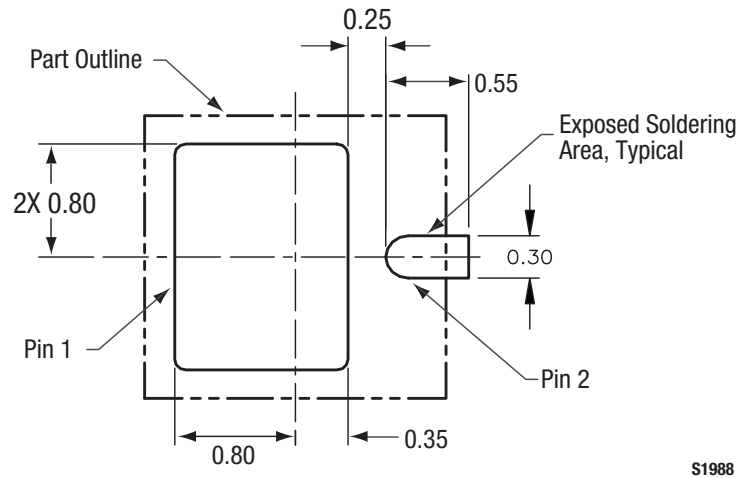


Figure 3. Forward Voltage vs Forward Current

Figure 4. SKY1324-087LF PCB Layout Footprint (Top View)

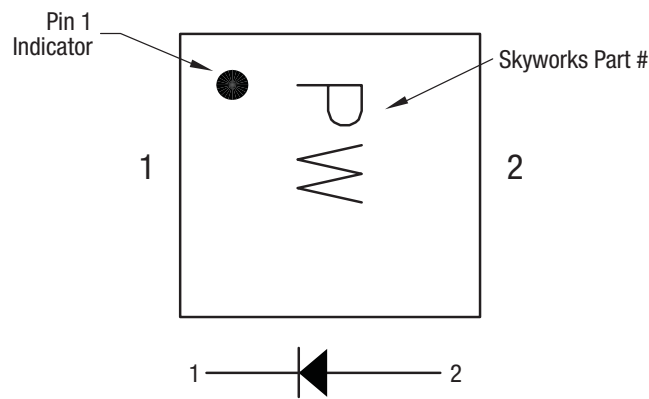
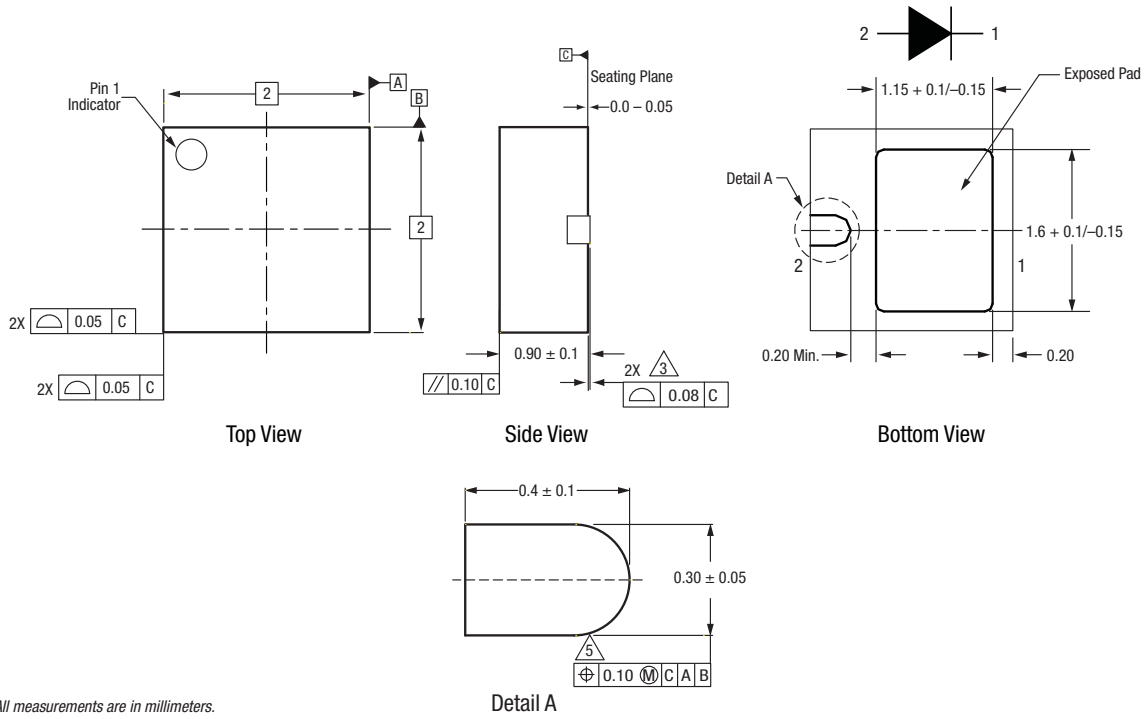


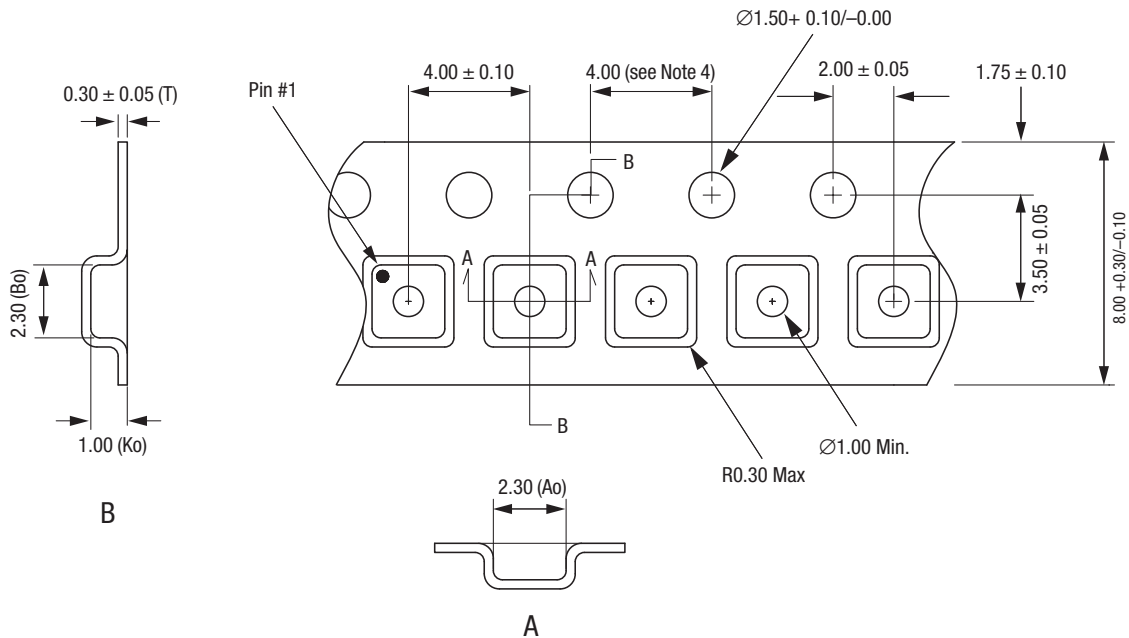
Figure 5. Typical Case Markings (Top View)
